Ken Imler – He informed the board that he sold a piece. Ken has created a spread sheet to track the volunteer hours and will be responsible to update this document. As more people join this will be reconciled.

John Creighton – Showed the board all the name tags he made. These are laminated and can be given to new members. A feature was putting the names on both sides. Nice job.

- Leslie Scott will be at the PACE Center along with Paul Valdez and Ulla Meyer to give "award winners" their oversized checks. The reception will be on April 1<sup>st</sup>. The oversized checks will be done by Sundance printing company in Parker.
