BUSINESS:

Treasurer Review – Bank balance \$22,440 motion to approve, all in favor

Website Review – Juliette Forestry is PAG's "webmaster". Jim will be meeting with her to thoroughly update the website.

Volunteers – volunteer hours; Charlie suggested PAG bucks, the board agrees that there are discrepancies under the volunteer hours for members. A majority of members do not volunteer. Board will table issue for next meeting – incentive option for members vs consequence.

SHOWS – update from Jim. Tadashi's is doing well – Tadashi takes care of everything – Tadashi really working with Deep Space to integrate in to a gallery. Tamiko inquired about liquor license with SJ, needs a check for \$300 and another check for \$400 for 3 separate licenses for three separate licenses or 4 licenses for four separate licenses. Tamiko will retain three licenses for \$300 from the board. Castle Rock show went smoothly for the initial hanging.

Marie – Venue Coordinator – she would like to increase our venues with local Parker and Lonetree businesses. She would like to do similar to Aurora "ART IN PLACES", go to the Chamber of Commerce and ask for list, ask members at next PAG meeting for ideas.

PP17 – Parker Perspectives 2017 – Charlie will be closing it down and will announce to see if anyone needs to claim any monetary award, otherwise he will close it down next PAG meeting

Alisha – GIRL SCOUTS update – board is in agreement that PAG is not in a position to take on the group – the board does not fit on the 2018 agenda. Alisha will follow up with the girl scouts leader and provide her with further ideas for the Girl Scouts.

Charlie - asking Alisha to pursue the marketing. Scholarships, sponsorship to ACC, SHEA HOMES and IREA, the website and FACEBOOK. SJ brought up PAG board member BRING the sponsor check TO THE SCHOOL and make some public appearance.

Judy Pendleton – would like more money for TEEN CLASSES. Charlie suggests up to \$500 for a new classes, SJ has discretion to produce Judy with more money for the teen classes.

Alisha – Farmers Market setting up a tent - SJ clarified PAG has a sales tax license for Parker – Alisha will look in to the issues with the sales tax and will contact the farmers market for more information.

Jim – February after meeting 'show' is covered. Coordinating a critique for after meetings twice this year. Still coordinating that looking for critique. Jim needs someone to coordinate the individual that will do the critique. Maria will follow up with her contacts. SJ said we have paid up to \$400 for a critique, yes – funds are available.

Marie – idea of exchanging art – board will pursue the idea in March.
