Abstract: The Illinois State Penitentiary Collection contains labor contracts, correspondence, invoices, employee policies and procedures, training modules and materials, inmate records, inmate publications, newspapers, scholarly publications, and photographs pertaining to the history of the Illinois State Penitentiary, specifically the Joliet and Stateville branches.

Acquisition Information: This collection has been composed of various accessions relating to the history of the Illinois State Penitentiary. There was no reasonable original order for these materials, so an order has been created for research purposes. All materials are appropriately labeled with their accession numbers, and more information regarding acquisition can be provided if requested.

Separated Materials: None.

Restrictions: Majority of the records in Series 3: Inmate Records are not available for research to the public. Prison records are legally restricted for 75 years from the date of the last entry in the record or file. These records will become available for research when they bypass the 75-year mark.

Background Information:

History:

The first penitentiary in Illinois was built in Alton in 1831. The privately managed Alton prison quickly degraded as the inmate population outgrew the penitentiary. Dorothea Dix, a noted champion for prison and asylum reform personally petitioned the Illinois General Assembly to construct a new penitentiary after inspecting the Alton prison in 1847. To address the problem of over population, the General Assembly appropriated funds for a new 1,000 cell prison at Joliet. In May of 1858, 53 inmates were transferred from Alton to a small structure on the property that would become the Joliet Penitentiary. The inmates began the work of constructing the larger penitentiary around themselves. This included the quarrying of limestone from the vein which runs through Will County just a few hundred feet from the prison. The Alton prison was turned over to the federal government and used as a military reservation for Confederate prisoners.

In June of 1871, the Illinois State Reform School at Pontiac opened, the first facility for first time male offenders under the age of 26. The facility became the Illinois State Reformatory in 1892 and changed names again in 1933 becoming the Pontiac Branch of the Illinois State Penitentiary.

Menard was the next penitentiary to be built in Illinois. The penitentiary was primarily built by prisoners transferred to the site from the Joliet Penitentiary, completing the first cellhouse in 1878 and the second in 1890.

With a second Illinois State Penitentiary open, in 1889 the General Assembly passed a law requiring all female inmates be sent to the Joliet Branch. They originally housed all female inmates on the fourth floor of the Administration building, but by June 1895 a women's prison was opened across Collins St. from the Joliet prison. This facility was used until the 1930s when the State Reformatory for Women was opened in Dwight.

Beginning in 1909 reports of unsanitary and dangerous conditions at the Joliet Penitentiary emerged and calls for closure were made. The state began funding for acquisition of lands for a new prison near Joliet. The new institution would house the Joliet inmate population and the old site could be abandoned. The Stateville branch opened in 1926, but it did not lead to the closing of the Joliet Branch. The Joliet Penitentiary remained active until 2002.

Scope and Content Arrangement:

The Illinois State Penitentiary Collection contains labor contracts, correspondence, invoices, employee policies and procedures, training modules and materials, inmate records, inmate publications, newspapers, scholarly publications, and photographs pertaining to the history of the Illinois State Penitentiary, specifically the Joliet and Stateville branches. The collection has been arranged into 6 series by document type and organized alphabetically.

There are several oversized materials in the collection. They have been listed in Series 6 of the collection and are listed in the finding aid with their original series number as well. All newspapers can be found in oversized storage drawer 6, blueprints are housed in oversized storage drawer 2, and all other materials are housed in oversized storage drawer 5 located in the Curator's Office.

Scope: The materials contained this series include institutional statistics, correspondence from Warden

Joseph E. Ragen, records relating to labor contracts with the Joliet Penitentiary, policies, and procedures for employees of the Illinois Department of Corrections, and additional records pertaining to the history of the Illinois State Penitentiary. Materials in this series have been arranged chronologically.

Of note, is an inmate labor contract and catalog for Ratan and Reed Co., a wicker furniture manufacturer, who had a factory located inside the Joliet Penitentiary. Companies such as Ratan and Reed Co. were allowed to contract labor from inmates for a set fee each day, creating a surplus of income to the penitentiary. By 1904 private businesses contract prison labor for profit was abolished.
