- Martha first week successful with bumps, clients didn't show up in January they aren't ready, using hot spots at most sites
- Barb installed secure router system, passed security but wanted to do better, people without docs takes a lot of time, acuity scheduling
- Tom first week hard with rusty skills, at capacity, 110 returns since opening, some volunteers traveling and out with illness, software running slow
- Jerry Opened on 31st with 9-10 clients, then 15, then 20 ramping up, new volunteers are learning
- Adrian AmeriCorps team, 4 returning volunteers, 2 new bilingual volunteers, 8
   AmeriCorps members are savvy and filling all positions, 13 clients first day, following
   Tuesday 50, 2022 \$1.3 million, 2023 \$2.8 million with AmeriCorps, stay on track to
   beat last year, team has adapted quickly and returning volunteers are mentoring, 5 sites
   M-F and 3 Saturday locations, KOAA news spot, CDPHE call for outreach
- Mary Rifle started today, hot spots have been tricky with cell service, Glenwood starts tomorrow, 7 today and 18 tomorrow, lots of calling back 175 people to make appts
- Vicki uses router and recommends that over hot spot, all locations have allowed own router, recommends Sign-up Genius for appointments, start the 8th - 45 appts
- Pat not filing until after the 12th, packets at food distribution, My Free Taxes promotion,
   6 roadtrips to smaller communities
- Jon rocky start with state, booked through February, looking into Acuity
- Debbie opening on Feb 17th, first come first served, they are ready
