Amazon delays

i. There have been some lengthy delays in Amazon deliveries this year. When you are ordering supplies, we recommend you check other vendors as well to see if they can get you the supplies you need in a reasonable amount of time, assuming the cost is comparable. You can still order from Amazon, just be aware there may be shipping delays on their end.

### 4. General Site Updates

- Martha: have been doing rural visits to High Prairie Library in Peyton. Eight volunteers, five hours, and completed 29 returns. Also went to Alamosa for four days and did 58 tax returns. Community was very appreciative of their service. Will do High Prairie once more in March and then again in April.
- Tom: Finding that Colorado returns taking a lot of paper. Has started to double side the returns.
  Had a client that gave wrong mailing address, customer was able to call IRS and correct the
  mistake. Has also found that ID.me does not work for most people not intuitive and difficult to
  navigate. 1095As are problematic this year.
- Vicki Now in 4 locations. Volunteers are a wonderful team. 95% full on appointments. Estimate about 500 appointments a year with 22 volunteers. Weather has been unpredictable and an issue, but they rebook appointments. Don't want to turn anyone away due to weather. They work closely with AARP.
- Adrian Local AARP that normally files taxes is not doing their program this year, so they have been able to absorb some of the volunteers. Estimate will do over 4k returns this year.
   Publicizes through press releases in local newspaper, social media, and website. Biggest need for program is more preparers. They are working on recruiting.
- Jerry doing ok in Longmont in new space. Similar struggles as other sites around 1095As, IP PINs, wrong names in places, etc. Had an unusual situation this year: 1042-S. Has not been able to find much information on this particular form.
- Tom: Medicaid Waiver W-2s, for instance if people who are certified CNAs and taking care of their own disabled child and are paid and that's excluded from income. That is covered in the 4012. It used to be you would get a W-2 where it would show the Medicaid waiver payment and not anything in gross income, but they are not coming that way anymore. The customer/client has to tell you it is a Medicaid waiver payment. Some places are paying them on 1099 NECs. It can be on a 1099 NEC, but they don't tell you how to handle it. Tom researched it and you put as an expense the exact gross income and say it's a Medicaid waiver payment. This will essentially wipe it out.
