Eligibility

• Age Restriction: You must be 18 years or older to participate.

Ticket Sales

- 1. **Pricing:**
 - o Tickets are sold in bundles: 6 tickets for \$5.
 - o Purchases must be made in **increments of \$5**. No single tickets are available.
- 2. Purchase Locations and Times:
 - o **Online:** Tickets can be purchased at www.parklawn.com.
 - **Availability:** Thursday, 9 AM to Tuesday, 3 PM.
 - After submitting an online purchase, you will receive an email receipt for your records.
 - Tickets purchased online will be filled out by **trusted committee/volunteer members** from Park Lawn.

- 3. **Deadline:** Ticket sales end at **6:40 PM** on drawing days (Wednesdays).

Drawing Details

- 1. Weekly Drawings:
 - o A single ticket is drawn at 7:00 PM every Wednesday.
 - o If the Queen of Hearts is not drawn, the jackpot rolls over to the next week.
- 2. Winner Notification:
 - Present Winner: Must check in with Emcee Tim Newsome within 10 minutes of the Facebook Live broadcast ending.
 - Present criteria:

- Ticket must match the name or initials and phone number on record.
- Winner must provide a valid ID for verification.
- o **Not Present:** If the winner is not present, 50% of the pot is awarded.

3. Winning Ticket Information:

- o If the Queen of Hearts is not revealed, the ticket will be **stored in the sleeve** in front of the chosen card on the board.
- o The **phone number will be blacked out** for privacy.

4. Online Results:

- Winning card position and card face value are posted on the Park Lawn Facebook page and At The Office Facebook page.
- Winner's names are not posted for privacy.

Payouts

- 1. **Queen of Hearts:**
 - o **Present Winner:** 60% of the pot to the winner, 40% to Park Lawn.
 - o **Not Present:** 50% to the winner, 50% to Park Lawn.
- 2. Special Cards:
 - o Ace of Spades: Free appetizers for a week for an entire year (restrictions apply).
 - o **Joker** (Kill Card): \$250 prize; board resets, and the jackpot rolls over.
 - Aces: \$200Kings: \$150
 - Queens (other than Hearts): \$125
 - o **Jacks:** \$100
 - o **Numbered Cards (2–10):** 24 tickets into the next week's drawing.
- 3. Board Reset:
 - o If the Joker is drawn, the board resets, and the jackpot rolls over.

Ticket Guidelines

- 1. Required Information on Tickets:
 - o Full Name or Initials.
 - o Phone Number.
 - o Card Position (e.g., #14).
 - Examples:
 - Full Name: "John Doe 777-888-9999 #14"
 - Initials: "J D 777-888-9999 #14"
- 2. Accuracy is Crucial:
 - o **Illegible or incomplete tickets** will be discarded.
 - o Players are responsible for ensuring their tickets are filled out correctly.
- 3. Weekly Ticket Colors:

- o Each week features new ticket colors and sequences.
- o **Old tickets are invalid** for new drawings.

4. Ticket Handling:

- o After each drawing, all tickets from that week are **emptied** from the raffle box.
- o Ticket sales for the next week begin immediately after the drawing.

Special Prizes

- Ace of Spades:
 - Winner receives free appetizers for a year (**restrictions apply**).
- Joker:
 - o Winner receives \$250, and the board resets.
- Face Cards & Aces:
 - Aces: \$200Kings: \$150
 - o Queens (excluding Hearts): \$125
 - o Jacks: \$100
- Numbered Cards (2–10):
 - o Winner receives **24 free tickets** for the next week's drawing.

IRS Compliance

- 1. Reporting Requirements:
 - o Winnings over \$600 and 300x the ticket wager must be reported to the IRS.
 - o Park Lawn will issue a **W-2G form** for winners receiving over \$1,500.
- 2. Tax Withholding:
 - o For winnings over \$5,000, federal income taxes will be withheld upfront by Park Lawn.
 - o The winner will receive the **net amount** after taxes.
 - o The winner must report the **gross winnings** and **withholding amounts** on their tax returns.
- 3. **Personal Information:**
 - Winners must provide all necessary details, including their Social Security Number, to complete the W-2G form.
 - o **Failure to comply within 30 days** of notification will result in the board resetting, and the pot rolling over.

Additional Notes

- **Privacy:** Only the winning card position and card face value are shared publicly.
- Ticket Disqualification:
 - o Tickets missing required information, or containing errors, are disqualified.
- Changes:
 - o Park Lawn reserves the right to:
 - Adjust sales dates and times.
 - Amend rules before any weekly drawing.
 - Postpone drawings as needed.
- Payout Timeline: Park Lawn may take up to 30 days to process and pay out winnings.
