ANTI-TOBACCO PROGRAMS: THE AGENCY CONDUCTS TOBACCO USE PREVENTION SERVICES FOR KINDERGARTEN THROUGH TWELFTH GRADE STUDENTS INCLUDING A PEER MENTORING PROJECT AND SPECIAL HELP FOR HIGH-RISK TEENS. THROUGH SMOKE FREE MOVIES PROJECT, THE ORGANIZATION WILL BE RECRUITING BAY AREA TEENAGERS, EDUCATING THEM ABOUT THE IMPACT OF "TOBACCO IN THE MEDIA" AND THEN TRAINING THEM TO ADVOCATE THE FILM INDUSTRY TO ADOPT "THE FOUR SOLUTIONS."
